International travel advice continues to be updated frequently and is available [here](#).

The [latest R number](#) range for the UK is 1.3 – 1.6 and the growth rate range is between +5% and +9%, meaning that the rate of new infections is estimated to be growing by between 5% to 9% every day.

The government identified a [data transfer issue](#) overnight on Friday 2nd October in the automated process that transfers positive COVID-19 cases data to Public Health England. It has now been resolved. This has caused some inaccuracies in the reporting of positive cases. The cases published for 3rd and 4th October include 15,841 additional cases with specimen dates between 25th September and 2nd October — they are therefore artificially high for England and the UK.

The Prime Minister, Boris Johnson, led a press conference on Wednesday 30th September, supported by the UK's Chief Medical Officer, Chris Witty, and the UK's Chief Scientific Adviser, Sir Patrick Vallance. They described the surge in reported cases across the UK and the need for concerted action to control the virus. On Thursday, 1st October, the Secretary of State for Health and Social Care, Matt Hancock, made an oral statement to Parliament about the extended and enforceable measures being introduced in the North East and North West of England to control the virus. His statement is available [here](#).
